December 29, 2016 Special Meeting

The Clear Lake City Council met in special session on Thursday, December 29, 2016, at 5:45 p.m. in the Conference Room of the Municipal Building with Mayor Gordon Lee presiding. Those present were Alderman Kelli Bauman, Ramona Drake, Gary Eide, Carey Holt, Tim Hulscher, and John Keimig. Also present were Todd Boyd, Don Ebbers, Ellen Schmahl and Ken Rieste.

The Pledge of Allegiance was said.

The agenda was presented for review. The agenda was amended to change the Sales Tax Subsidy amount to \$34,862.23 Motion by Holt, seconded by Hulscher to approve the agenda as amended. All voted yes. Motion carried.

The Deuel County Zoning Board of Adjustments asked to have the Community Center fee waived for their January 9, 2017, meeting. No action was taken.

Liquor Licensees are having issues getting the Notice to Supplier forms from suppliers. The operators must have a signed Notice to Suppler form each year from any supplier they purchase hard liquor from per their Alcoholic Beverages Operating Agreement.
